

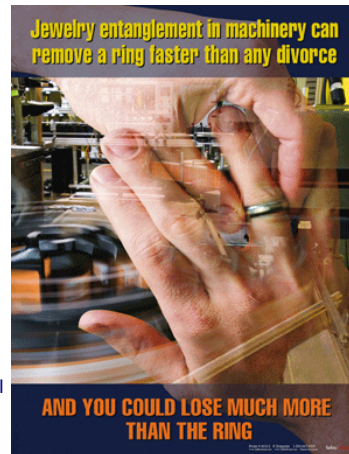

The **Attorney General of Canada** introduced Bill C-45 to establish criminal liability for organizations and individuals when they fail to take reasonable steps to prevent workplace accidents that affect workers or the public in general.

Effective March 31, 2004, the expanded legal mechanisms that engage corporate liability will have effects in many areas, including environmental, occupational health and safety offences.

The amendment states that: **"Every one who undertakes, or has the authority, to direct how another person does work or performs a task is under a legal duty to take reasonable steps to prevent bodily harm to that person, or any other person, arising from that work or task."**

The legislation will expand the legal mechanisms that engage corporate liability, which will have effects in many areas, including environmental and occupational health and safety offences.

Punishment for breach of duty by officers of an organization can bring penalties of fines that reach tens of millions of dollars, and jail terms for life.

So, it is more critical than ever for **facility managers** across the country to make sure their **staff** is familiar with the elements and work together towards preventing environmental disasters, occupational diseases and safety related accidents and injuries.
